We have a very unique opportunity presented to us. The Minnesota Department of Health is in the process of reworking the Lodging Rules and Codes and has requested input from us in the industry. The first meeting was held August 27th and is working under the title Umbrella Lodging Workgroup. What we would like is CMR members in the conversation to help and shape the future of our industry. Below describes workgroups sub-groups.

§ Lodging Statute and Rule Development Subgroup •This subgroup would be responsible for reviewing current existing standards and regulations for independent living apartments, lodging establishments, hotels, motels, rental properties and other similar facilities and developing a standard or set of flexible standards that could be used as a foundation for other more specific lodging situations.

§ **Revenue and Funding Stream Subgroup** •This subgroup would be responsible for discussing tax requirements, federal and state supplemental payer options and other financial burdens or concerns that exist in lodging facilities.

§ Health Regulation Division Operators Subgroup • This subgroup would be responsible for performing a gap analysis of the existing regulations in Health Regulation Division regulated facilities and identifying what standards if any to apply to these businesses.

§ Occupancy Subgroup – Fire Code, Zoning & Building •This subgroup would be responsible for evaluating existing definitions and laws pertaining to occupancy in lodging facilities to provide guidance and recommendations to the other subgroups and make recommendations for streamlining regulations when possible.

§ **Department of Human Services Operators Subgroup** •This subgroup would be responsible for performing a gap analysis of the existing regulations in Department of Human Services regulated facilities and identifying what standards if any to apply to these businesses.

We (Mark, Joel & I) are not sure what the total process or commitment will be, but believe this is a very important group to get involved with. We need others to join us in the reshaping of the Rules and Codes that govern our businesses. -Tim Aarsvold"

Tourism Advisory Council Report

The University of MN reported the results to date on their study of the effect of year-round school on travel patterns.

- It has the potential to re-distribute travel time away from the summer into the rest of the year
- It is unclear if it would increase or decrease total travel over the year
- It is important to distinguish among: state policy that allows the practice, states/districts that provide the option, and districts that switch substantially or entirely to year-round school
- Conclusions from this round of study indicated that: School schedules do interact with travel in a meaningful manner
- State level policies do not seem to matter; all the action is happening at the local level
